- #1. Gas Price: \$1.72 Diesel Price: \$1.53
- #2. All paving on NV Maine Road is complete except for the narrows to the Village Line. We had the Town of Spencer, Tioga, Owego, Candor, Berkshire, The County, Maine, and Nichols helping us. Also, two men from the Village of Newark Valley were flagging for us. The two loaders at the pit were, Town of Tioga and Town of Owego. Also used was, Town of Nanticoke's Roller.
- #3. To use up the #1's #2's and sand, the intersection of Irish Town Road was done. That helps keep the gravel from coming out onto the new pavement of NV Maine Rd. this will be sealed when we do NV Maine Rd.
