- #2. All the projects with stone and oil are complete. I did do 1 more road, which the oil price was lower than estimated in April and we had the stone. I will have the exact cost for Dr. Knapp S. in the July meeting with amendment for the agreement to spend highway funds. If the monies are ok I might do more but waiting for the bills.
- #3. I haven't had time to get into the wall on NV-Maine Rd. yet. Basically explore to see what is happening, I will keep you informed.
- #4. The shoulders should be done by the July meeting on NV-Maine Rd.
- #5. We have gone around and re-worked holes on gravel roads only. The DEC permit I finally received for truck #84. Now we are waiting for a valve that wore out in the back, which closed on its own while loading water and blew out all the piping. We are replacing all.
- #6. We will be getting some type of dust control out shortly. Harford gas does have brine, but only 19% salt. It will take 3 or 4 times to get enough. No cost for now.

A regular meeting of the Town Board of the Town of Newark Valley, Tioga County, New York was convened in public session at Hutchinson Hall, 109 Whig Street, in the Town of Newark Valley, New York on June 21, 2016, at 7 pm, local time.

# STATUTORY INSTALLMENT BOND RESOLUTION DATED June 21, 2016

A resolution authorizing the issuance of one statutory installment bond of the Town of Newark Valley, Tioga County, New York in an aggregate principal amount not to exceed \$162,000.00 pursuant to the Local Finance Law to finance the purchase of a 2016 Volvo dump truck with a

tenco box, plow, wing, and sander, and delegating the power to issue the Statutory Installment Bonds to the Town Supervisor.

BE IT RESOLVED, by the Board of the Town of Newark Valley, Tioga County, New York (the "Town") by the favorable vote of the three Board members present at the meeting, as follows:

SECTION 1. The specific purpose (hereinafter referred to as "purpose") to be financed pursuant to this resolution is the purchase of a 2016 Volvo dump truck with a tenco box, plow, wing, and sander at an estimated maximum cost of \$192,950.00.

SECTION 2. The Board plans to finance the total cost of the said purpose by a down payment of \$30,950.00 and the issuance of a statutory installment bond of the Town in an amount not to exceed \$162,000.00, hereby authorized to be issued therefor pursuant to the Local Finance Law. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150 - 2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the purpose described herein.

SECTION 3. It is hereby determined that said purpose is an object or purpose described in Section 11.00(a)(28) of the Local Finance Law, and that the period of probable usefulness is 15 years.

SECTION 4. It is hereby determined that the proposed maturity of the obligation authorized by this resolution will not be in excess of five (5) years.

SECTION 5. The bond authorized by this resolution shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law. The faith and credit of the Town are hereby irrevocably pledged for the payment of the principal of and interest on said bond as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on said bond becoming due and payable in such year. There shall annually be levied on all the taxable real property of the Town a tax sufficient to pay the principal of and interest on said bond as the same become due and payable.

SECTION 6. Subject to the terms and contents of this resolution and the Local Finance Law, the power to issue the statutory installment bond authorized by this resolution, and the power to prescribe the terms, form and contents of said bond, and the power to determine to issue said bonds providing for substantially level or declining debt service, are hereby delegated to the Town Supervisor, Stuart Yetter, Chief Fiscal Officer of the Town. The Town Supervisor is hereby authorized to sign any bond issued pursuant to this resolution, and the Supervisor is hereby authorized to affix the corporate seal of the Town to the bond, if necessary, and to attest to such seal.

SECTION 7. The Town Supervisor is further authorized to take such actions and execute such documents as may be necessary to ensure the continued status of the interest on the bond authorized by this resolution, as excludable from gross income for federal income tax purposes pursuant to Section 103 of the Internal Revenue Code of 1986, as amended (the "Code") and to designate the bond authorized by this resolution as a "qualified tax-exempt obligation" in accordance with Section 265 (b) (3) of the Code.

SECTION 8. The validity of said bond may be contested only if:

- (1) Such obligations are authorized for an object or purpose for which the Town is not authorized to expend money, or
- (2) The provisions of law which should be complied with at the date of the publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication, or
- (3) Such obligations are authorized in violation of the provisions of the Constitution of New York.

SECTION 9. The Town Clerk is hereby authorized and directed to publish this resolution, or a summary thereof, together with a notice in substantially the form provided by Section 81.00 of the Local Finance Law, in the Tioga County Courier, a newspaper having a general circulation in the Town, and hereby designated as the official newspaper of the Town for such publication.

The question of the adoption of the foregoing resolution was duly put to vote on a roll call, which resulted as follows:
