- #4 The dirt roads are taking their toll. They are mushy, rutty and Sh---y. You fill in the blanks.
- #5 Some of the emulsion roads are crumbling also. They need a lot of maintenance this year.
- #6 Start thinking about the road paving projects. I haven't received any cost on anything yet. I am waiting to look at them when they are all cleared.
- #7 A lot of shoulders were rolled up and we are going to pick them up.
