Highway Report February 16th 2010

#1. Gas Price: \$2.2477 a gal Diesel Price: \$2.5946 a gal

#2. Truck #82 blew a main hydraulic line to the pump and #85 had a fuse short, which made it run on 3 cylinders, they both were fixed. Also we put a new block heater in the backhoe.

- #3. I contacted Tioga County Soil and Water in reference to the re-line of the cross over pipe on Davis Hollow Rd. They haven't come up yet.
- #4. The last County Meeting, all the Highway Superintendents were informed of the narrow banding requirements from the FCC. We will be checking with the radio repair people, (we have to see), if our radio's can be changed. The radios might already be on narrow band, we don't know yet, See Attached.
- #5. The Ting Committee of the Road Usage, for gas wells, gave us Highway Superintendents a copy of a Highway Agreement, which, PA Town Ships and Chesapeake Gas Company are using. They did say that the Cog-Supervisors would be getting a copy also. The Gas Companies want the Agreements simple. See Attached.
- #6. The Ceiling Panels are done! We have the paint for the Beams; we will be working on them shortly. Stop by and take a look!

#7. <u>Tentative dates for spring clean up.</u>

April 29th Seniors April 30^{th and} May 1st for the rest. "No wood can be burnt." No Wood - No Brush? Tire Trailer? Note: This is One week before Village Yard Sales. Also this is done so we can get to the roadwork early. Not after yard sales either. Already talked to the Village if they want to do it on our week they can, if not they are on their own.

The Town Board and Superintendent Meade discussed the status of county-wide decisions on potential regulations for gas drilling and the roads. Superintendent Meade reported that Owego and Candor were going ahead on their own.

Franchise Cable Agreement

Supervisor Yetter brought up the proposed Time-Warner Cable agreement for discussion. Superintendent Meade noted that the free cable for the schools, highway department, fire department or town hall was not mentioned in the agreement.

Attorney Lewis noted that the agreement was "boiler plate" or general. He requested copies of the cover letter for the current proposal, the prior agreement with Time-Warner

and the proposal from Haeffles for comparison purposes. He indicated that there were points that could be negotiated with the cable company for better coverage, expansion of services and so forth.

Planning Board

Hans Peeters reported that the Planning Board had prepared a draft "Burning, Outdoor" ordinance to conform with the No Burning Law from the State Department of Environmental Regulations. The Board and Mr. Lewis, Attorney to the Town, read the draft, and recommended that changes be made the requirements clearer to the citizens of the town. Mr. Lewis will assist Mr. Peeters and the Planning Board to rewrite the ordinance.
