## **Highway Report November 2012**

- #1. Gas Price: \$3.48 Diesel Price: \$3.57
- #2. All the FEMA Big Jobs are completed. We will have some ditches to fill that we can do in time. Next month I'll have all the bills in for the FEMA Account. There will be money left.
- #3. I did get some 1<sup>st</sup> Lime Stone in for next year, which is for Lawrence Rd, Gage Rd, Murphy Lane, Harnecky Rd, WoodLand Drive, Highland Drive, Ridge Haven Drive, Grandview Drive, and possibly Irish Town Rd. If I could have bought the oil this year it would have been nice. The stone is stock-piled behind the garage, along with an extra pile of Snow Sand.

#### #4. Repairs:

Truck #89 we replaced 3 air tanks and put 8 rear tires on. (2006 Volvo)

# A RESOLUTION OF THE TOWN OF NEWARK VALLEY AUTHORIZING THE ADOPTION OF THE TIOGA COUNTY MULTI-JURISDICTIONAL ALL-HAZARD MITIGATION PLAN

**WHEREAS**, all of Tioga County has exposure to natural hazards that increase the risk to life, property, environment and the County's economy; and

**WHEREAS**; pro-active mitigation of known hazards before a disaster event can reduce or eliminate long-term risk to life and property; and

**WHEREAS**, The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre and post disaster hazard mitigation programs; and

**WHEREAS**; a coalition of Tioga County municipalities with like planning objectives has been formed to pool resources and create consistent mitigation strategies within Tioga County; and

**WHEREAS**, the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of natural hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating and revising this strategy;

## **NOW, THEREFORE, BE IT RESOLVED** that the Town of Newark Valley:

- 1) Adopts in its entirety, the Tioga County Multi-Jurisdictional All-Hazard Mitigation Plan (the "Plan") as the jurisdiction's Natural Hazard Mitigation Plan, and resolves to execute the actions identified in the Plan that pertain to this jurisdiction.
- 2) Will use the adopted and approved portions of the Plan to guide pre- and post-disaster mitigation of the hazards identified.
- 3) Will coordinate the strategies identified in the Plan with other planning programs and mechanisms under its jurisdictional authority.
- 4) Will continue its support of the Mitigation Planning Committee as described within the Plan.
- 5) Will help to promote and support the mitigation successes of all participants in this Plan.
- 6) Will incorporate mitigation planning as an integral component of government and partner operations.
- 7) Will provide an update of the Plan in conjunction with the County no less than every five years.

#### **Council Members & Committees**

Councilman Tomazin discussed with the Board his concerns about the Mobile Home Law with concerns about hardship cases. There was a lengthy discussion on this issue.

It was brought to the Town Board's attention that a mobile home on the Crofoot property has to be addressed. Supervisor Yetter said he would talk with Code about it.

Supervisor Yetter asked the Board if they would be agreeable to him proposing to the Highway Union a one year contract renewal, keeping the same insurance policy with a .\$55 increase in pay. They need a contract. The Board is in agreement.

Joe Onofrio gave a rough estimate to the Clerk for cabinets and countertop for the conference room. His estimate is \$5,700.00. The cost is more than \$2,000.00 so we need three quotes. The Board discussed the cabinets and cost. It was decided that Councilman Cheresnowski would come in next week and look over the project for measurements and cost.
