# MESSAGE FROM THE SUPERVISOR'S DESK

Here at the Town Hall we have just wrapped up another budget season. Things are looking good for the 2014 tax year. Our 2013 revenues met all expectations and expenditures are all coming in at or below the budgeted levels. We were able to stay under the state mandated tax cap of 1.66% our local tax rate is going up less than 1%.

As a result of good management primarily by the Board and the Highway Department we are able to increase the funding for highway maintenance. This allows us to keep up our preventative maintenance plan to preserve the existing roads and do some improvements.

Expenses continue to rise in the snow removal budget as sand and salt costs continue to increase. The Highway Department will do their best to maintain safe passable roads at a cost we can afford. I ask everyone else to do their part by keeping the proper tires on their vehicles and drive slowly and cautiously.

We have also started to plan for the construction of a salt storage facility and to put money in the capital reserve to move towards that goal.

The Town also has a need for people to serve on various advisory boards. We have a need for members on the Board of Assessment Review, the Variance Board and the Town Planning Board. Anyone interested is asked to contact me or any Board member for additional information.

I would like to thank everyone for the opportunity to serve the residents for an additional four years. I wish everyone a safe and joyous holiday season and a Happy New Year.

#### DOG LICENSES

# If you own a dog and live in the Town of Newark Valley:

Newark Valley Town Law requires you to license your dog(s). Your dog **must** have a license. In order to get a new dog licensed, you must have a current Rabies Certificate and the appropriate fee amount. If your dog is spayed or neutered, please provide a certificate, so you can get a discounted license fee. Please put the dog tag on the collar of your dog (highly recommended) then if your dog becomes lost, we will be able to identify the animal and owner easier. The tag is good for the life of the dog and just like the license is nontransferrable. If the tag is lost, a new one can be issued for a charge of \$3.00.

# You can get a new license or renewal license by mail. You will need:

A current Rabies Certificate (all the required information about the dog and you should be on the Rabies Certificate)

- A spayed or neutered certificate, if it applies
- A check or money order made out to the Newark Valley Town Clerk in the amount of **\$7.50** for a spayed or neutered dog or **\$15.50** for an unspayed or unneutered dog for a year license
- Mail to: Newark Valley Town Clerk, 109 Whig Street, Newark Valley, NY 13811

We will mail back all originals, the license and if needed, a license tag.

If you no longer have your dog, if you change your phone number, or you have a change of address (even if you move to another town), please contact the Town Clerk's Office to update our records. Your cooperation is vital in keeping our records current. In doing so, you won't receive a renewal or delinquent notice.

Highway Supt. -Charles Meade 642-9927 Every month we have to generate delinquent dog notices and we do not like to send them any more than you like to receive them. So...to avoid this, please update us on the status of your dog(s) and renew your dog license(s) promptly. Thank you.

Failure to license your dog or renew a license is a violation of the Town Law and will result in an appearance ticket with a maximum fine of \$250.00.

#### HANDICAP PARKING

If you need a handicap parking tag, you need to get a form from us, or your doctor's office, have the doctor fill it out, (both of you need to sign and date it) and bring it into our office along with your driver's license. We will then fill the request from the application. There is no cost to you. You must live in Newark Valley to have this office issue you one. If you live in Newark Valley, you must get your tag here in Newark Valley.

#### MARRIAGE LICENSES

Getting married? If you plan to get a marriage license from us, please note the following:

License Fee is \$40.00, payable by check or cash.

**1.** Both Bride and Groom must be present at time of the application.

2. Proof of identity (driver's license, non driver's license)

**3.** Certified Birth Certificate for proof of birth, name and age.

4. Certified Divorce decrees from all previous marriages.

5. There is a 24 hour waiting period between the purchase of the license and the wedding ceremony.

6. The license is valid for only 60 days.

7. The license has to be filed where it is purchased, not where the marriage takes place.

You may apply for a marriage license in any Town or City office in New York State. If you choose to apply in Newark Valley, you must arrive one hour prior to this office closing.

If you need a copy of a birth, marriage, or death certificate, contact the office at 642-8746. You will need to fill out a form. There is a \$10.00 charge for each copy.

Hunting and fishing licenses are still available for purchase. Have a Very Merry Christmas and Happy New Year!

#### TAX COLLECTOR

Tax collection hours will be on the tax bills and are as follows:

## January and February: Monday - Wednesday 10 a.m. to 1 p.m. Thursdays 10 a.m. to 5 p.m. Closed Fridays. No Holiday collections.

**If you want to pay your tax bill in December** please call the office at 642-8746 between now and December 20th to get on the "list" of December payers. This is a fresh list, there are no carryovers from last year, or previous years. We will call you as soon as the tax bills are available so you can come in and pay or mail your payment before 01/01/2014.

If you expect to get a Town and County Property Tax Bill and have not received it by January 10, 2014, please call our office at 642-8746 and we will send you a copy.

If you have a mortgage with escrow, your taxes are probably paid by you as part of your monthly payment. Then, your mortgage company or some designated processing company makes the actual tax payment on your behalf. We get notifications from most mortgage companies to send the tax bill to that company directly, which we do. However, in the absence of any notification, we will send the bill to you. **As the property owner, you are responsible for the taxes.** 

If your mortgage company or bank is supposed to pay your taxes through an escrow account, or will not be paying your taxes anymore, please make sure they notify Tioga County Real Property by filling out Form 953 and faxing or mailing it to them at 56 Main Street, Owego, NY 13827. Hopefully, this will alleviate any of the problems we have had in the past.

Payment can be made in person or by mail. If you mail your payment, it is considered paid on the **postmark date** (**not** the date of the check) so, be sure that it is postmarked no later than the date it is due. If you do need to pay late, please include the interest amount, as we cannot accept a payment for more or less than the **exact amount** due. If you do not pay in person, or your mortgage company pays on your behalf, a "PAID Receipt" will be mailed to your address of record. If that address has changed, please notify the assessor at 642-8666.

We do not accept payment after May 31, 2013. Call the Tioga County Treasurer's Office at 687-8670 to find out how to pay your tax bill.

The Northern Tioga Neighbors Network (NTNN) is currently looking for interested parties to volunteer and/ or join the Board of Directors. NTNN is an all-volunteer nonprofit based out of the Hubbard Resource Center in Richford. NTNN serves clients in Richford, Berkshire, and Newark Valley. Volunteers are needed to provide services such as transportation to doctor's appointments, food pantries, and other needs throughout the community. Furthermore, the volunteers at NTNN provide services such as friendly home visits, assistance with applying for benefits, and minor home maintenance for disabled and elderly residence.

NTNN's service allows for scores of residence to remain at home rather than being placed in residential care. Thus, NTNN improves the quality of life for friends, neighbors and loved ones while saving families and tax payers the expense of these services. As of September 2013, NTNN has served more residence and has traveled more miles than all of 2012. Thus, the need for volunteers now is greater than ever.

The ideal volunteer is someone that lives in Richford, Berkshire, or Newark Valley, enjoys serving others, and has a license and access to reliable transportation. There is no minimum requirement for the amount of hours for a volunteer to serve. Becoming a volunteer at NTNN is a great way to give back to the community while still being able to enjoy a flexible schedule. NTNN provides mileage reimbursement for volunteers, provides liability insurance while carrying out official business, and provides training and continuing education opportunities for volunteers.

#### **CODE COMMENTS**

Electrical Loads — As we approach the Christmas season, many Newark Valley citizens will be putting up decorative lights. I would remind you that extension cords can only carry so much electrical current. An overloaded circuit can cause heat, blown circuit breakers and potentially a fire. Let's have a safe end of the year by keeping an eye on how much load we put on our extension cords.

911 Signs — As I travel around town, I have noticed the improvement in the number signs on our homes and mail boxes. Have you noticed that the stick on numbers peal off every year or two? This is because of two reasons. 1. They are not manufactured to last forever. 2. If you do not pre clean the surface well before you stick them on, the numbers will be falling off sooner than they should. A more expensive but longer lasting solution is the reflective green aluminum signs. These are being sold at local hardware stores. Some of our regional fire departments are selling them at cost.

Remember — If you are not certain you need a building permit, just give me a call. There are no silly questions. It is best and least expensive to know you are ok upfront.
