# **NEWARK VALLEY ANNUAL SPRING CLEAN-UP DAYS**

Town and Village of Newark Valley Residents:

The Town of Newark Valley will be conducting Spring Clean-up on Friday, May 1st and Saturday, May 2nd. Items may be brought to the Town Hall, 109 Whig Street, and deposited in dumpsters at the rear of the property. Operating hours will be between 7:30 a.m. and 3 p.m. on both days. Residents 65 and over plus Town residents who are disabled and who wish to have their debris picked up on Thursday, April 30th, must make an appointment no later than Monday, April 27th, 2015, but not before April 1st by calling the Town Highway Department at 642-9927 from 9 a.m. to 3 p.m.. Debris and/or brush to be picked up or dropped off will be limited to one pick-up truck load per household ONLY. More than one pick-up truck load will be left for the homeowner to properly dispose of. NOTE: Due to the new DEC No Burning Law we will not be taking wood. That means no construction wood of any kind i.e.; plywood, boards, 2x4's, 2x6's, etc. We will take brush no bigger than 4 inches in diameter at the cut off area to be run through the brush chipper. No debris from Towns outside of the Town of Newark Valley will be accepted. This year we will be taking tires as well. They can be no larger than 16 inches and can be on rims. The cost is \$2.00 per tire and proof of residency is required at time of drop-off. All tires must be dropped off at the 109 Whig Street site. No tire pick-up will be offered during Senior pick-up day.

The following items **WILL NOT** be accepted:

Glass of any kind, paint cans or other hazardous waste containers, construction debris, shingles or tar paper, household garbage, batteries or recyclables.

The following items **WILL** be accepted:

Old furniture, brush 4 inches or less in diameter, mattresses, plastics, scrap metal, and appliances (with doors removed).

In this newsletter is a special insert for the dog enumeration. Please submit the attached form to the Newark Valley Town Hall by April 1, 2015. If this form is not returned, a home visit may be necessary by the Newark Valley Dog Control Officer to acquire this information.

If you have lost or found a dog, please contact the Newark Valley Dog Control Officer ASAP 24/7 @ (607) 642-3287.

Often I am able to just offer my assistance by being a contact individual and sharing the information as you search for your pet as well as being aware of any potential sightings.

Keep in mind as well that most individuals that report or retrieve a lost dog contact the Dog Control Officer so let's bring your pet safely home before transport to Stray Haven has to happen.

Kennel License—\$50.00 plus \$1.00 per dog for spayed/ neutered, and \$3.00 per dog for unspayed/ unneutered

Replacement Tag-\$3.00

Dear Village or Town of Newark Valley Resident:

The Dog Control Officer is conducting a census/enumeration of all the dogs living in the Village & Town of Newark Valley. Licensing ensures that all dogs have been properly vaccinated against rabies for the protection of you, your family and your neighbors. After licensing your dog – should you move, change your contact information, the dog is missing, the dog been transferred to another individual or the dog is deceased, please contact the Newark Valley Dog Control @ (607) 642-3274 to update our records.

It is very important that every household responds to the requested information regardless of whether you actually own a dog or not. If you wish to submit a license/renewal at this time, please review the licensing requirements below. Keep in mind that if your dog is not licensed, you may receive a court appearance ticket which could result in a maximum fine of \$250.00. When you license your dog, be sure to place the dog tag on their collar as it will assist in getting your dog back home should they ever become lost. Every dog that is picked up without an ID often ends up being taken to Stray Haven.

#### **FIRE MARSHAL FACTS**

2014 was a busy year for the Fire Marshal's office, there was a total of 127 fire safety inspections conducted in the Town of Newark Valley. A break-down of these inspections: 22 commercials, 24 reinspections, 6 public assemblies, 5 outdoor woodstoves, 9 fire investigations, 41 vacant & unsafe structure, 10 unauthorized outdoor burning, 6 woodstove & pellet stove, 4 multi-dwellings. We issued 71 outdoor burn permits, denied 3 for burn pile being to high. There was a total of 75 fire code violations cited, all violations were corrected before the end of the year, also we traveled over 600 total miles in 2014.

NEW CODE IS IN EFFECT

Effective Now!

There is a new rule that amends the Uniform Code by adding provisions applicable to "sparkling devices."

There are now new training requirements for Code Enforcement Personnel.

Orders to remedy now must be in compliance within 30 days.

All future permits and non completed permits that have truss type, pre engineered wood or timber construction must fill out a form with the code officer and affix a truss sign on their electrical box.
