## MESSAGE FROM THE SUPERVISOR'S DESK

The year of 2024 was actually pretty favorable for the Town of Newark Valley. All of our anticipated revenues came in over budget. The anticipated expenditures came in under budget. This allowed us to use some surplus to keep the tax rate from increasing a significant amount. It appears that we will also have some excess to transfer to our capital reserves accounts to help with future expenses. We are fortunate to have remained debt free for another year. Our financial well being is a result of hard work from our employees to keep expenses in line. The Highway Superintendent has been diligent about finding cost savings wherever he can. It has been a group effort that has paid off for the taxpayers. That being said we do have some expenditures looming on the horizon. We are planning the purchase of a new plow truck to the tune of nearly 350,000.00 dollars. While we have some savings for this purchase it is anticipated we will need to bond for part of the cost. We are also going out to bid for repairs on the Dalton hill bridge abutment. This will be an unknown expense until further research and bids come in. The Highway superintendent and the Town board are working to find the best and most economical solution to this issue.

As it appears we may be in for more of a real winter than we have been used to I would like to say a few things. Please slow down and be careful. Please equip your car with tires good for winter driving. The Town cannot keep all roads bare24 hours a day. Our crew works tirelessly during each storm to keep the roads as safe as possible. Mother nature has far more power at her disposal than we have.

When cleaning your driveways please remember it is illegal to push snow into or across the road. This activity could result in legal action against a homeowner

## Town Clerk-cont.

<u>Licensing your Dog</u>: Rabies Certificate and a Spay/Neuter Certificate are required. You will receive a tag that is good for the life of your dog. If you need to replace a tag, the fee is \$3.00.

Renewals: Renewal notices are sent mid-month. There is a \$10.00 late fee for a delinquent Dog License renewal. Please notify the office if your address or phone number has changed. If you no longer have your dog, or you have moved, please notify us so

## HANDICAP PARKING PERMITS FOR TOWN RESIDENTS ONLY

(Residents of the Village should go to the Village office).

- Please complete a DMV handicap parking permit form. (Available on our website, at the Town Clerks office, or your doctors office)
- You will need to have the form signed by your doctor; bring the signed and dated form along with your drivers license.
- There is NO charge for the permit.

## REGISTRAR MARRIAGE LICENSES

Getting married? If you plan to get a marriage license from us, please note the following:

FEE: \$40.00

Both bride and groom must be present for the application. The following are required:

- Proof of identity (driver's license, non-driver's license, passport).
- Certified Birth Certificate with a raised seal.
- Social Security number.
- Certified Divorce decrees from ALL previous marriages.

#### NOTE:

- There is a 24 hour waiting period between the purchase of the license and the wedding ceremony.
- The license is valid for 60 days.
- The license has to be filed where it is purchased, not where the marriage takes place.
- You may apply for a marriage license in any Town or City office in New York State.

January 1st - May 31st Monday thru Thursday 10 to 1 pm. January 1st - January 31st Wednesday evenings 5:30 PM to 7 PM February 5th - May 31st Every other Wednesday 5:30 PM to 7PM

Those wishing to pay early (in Dec) please call for amount and arrange payment Monday – Thursday between 10 and 1 pm. If you do not receive your tax bill and your taxes are not paid by your mortgage company/bank please call in January so that one can be re mailed or emailed to you or you can be given amount of bill over the phone.

If you sold property in 2024 and still receive the bill, please either forward to new owner if known or let me know so that I can send a bill to the new owner. If you purchased property in 2024 and do not receive a bill let me know as it may still be in the previous owner's name and I will send it to you. NOTE: Bills are printed according to the ASSESSMENT records. I do not have any control over what name or address is on the bill. Payment may be made by check, money order, or cash. Credit/Debit NOT ACCEPTED. ON-LINE PAYMENT NOT AVAILABLE. Mail in payments are welcomed. Payment must be postmarked for month being paid.

# STATUS OF HOPE CEMETERY MAUSOLEUM



In May 2024 an open house of the mausoleum was held. Over 120 people attended with very positive comments

The donations were very much appreciated.

Our Cemetery Treasurer opened a separate NBT account for the mausoleum funds.

Based on the feedback from the first open house, an October open house was held.

## Where we stand on progress:

We will be focusing on the outside deterioration. This will be broken down into Phases based on available funding.

An initial assessment of the roof, basement, foundation, and outside facade has been done.

Currently working on a formal Request for Quote for tradesmen bids.

Phase 1 will focus on the front exterior. This will include the removal of loose surface material, masonry resurfacing, and sealing.

We are hoping to get started as soon as we receive the responses to our requests for quotes approved.

## DOG DATA

#### TOWN OF NEWARK VALLEY ANNUAL ENUMERATION & DOG LICENSING LAWS

<u>LICENSING</u> – New York State requires that every dog over the age of 4 months - owned or harbored in New York State for longer than 30 days - must be licensed in the jurisdiction where the dog is being harbored - unless they are exempt pursuant to Agriculture and Markets Law §109. After licensing your dog – should you move, change your contact information, if the dog been transferred to another individual or the dog is deceased - please contact the Newark Valley Town Clerk @ 607-642-8746 to update our records.

**EACH HOUSEHOLD** - Please review and submit the dog enumeration form in this newsletter to the Newark Valley Town Hall by January 31, 2025. It is very important that every household responds to the requested information regardless of whether you own a dog or not. If this form is not returned, a home visit might be necessary by the Newark Valley Dog Control Officer to acquire this information.

## **CODE ENFORCEMENT NEWS**

Hope everybody is in good health. As you know, heating season is upon us. If you are thinking about installing any kind of heating equipment, such as, wood stoves, pellet stoves, gas heaters, basically anything with a chimney it needs a permit and to be inspected.

Another problem we have in the town, are junk vehicles. Our Junk Vehicle Law states that no more than two (2) unregistered vehicles are permitted on your property. All other vehicles have to be legally registered.

The Town Board of NV has passed Local Law for recreational vehicles and campers, which means living in a camper full-time is considered prohibited in Newark Valley.

A permit will be needed to occupy a camper/recreational vehicle in the Town. Such permit will be good for six (6) months in a twelve (12) month period, renewed every year.


